

**NAMA Ayurvedic Program Listing Application Checklist**

The National Ayurvedic Medical Association (NAMA) invites you to list your Ayurvedic educational program(s) on the NAMA website. *(Note: this is not a calendar of events)*. Schools and their programs must be operating legally as defined by their respective state regulations governing post-secondary and vocational schools. Ayurvedic programs meeting NAMA 500 hour Practitioner requirements must be approved by NAMA.

- Educational programs will be listed in one of four categories.
  1. Meets NAMA 500 hour practitioner level requirements  
*Complete: NAMA 500-Hour Practitioner Level Program Application*
  2. Provides less than NAMA 500 hour practitioner level requirements
  3. Are in the format of Seminars or Intensives 50 hours or less
  4. Are in the format of distance learning
- Graduates from NAMA approved 500 hour Practitioner Level Programs qualify automatically for NAMA 500 Hour Practitioner Level Membership saving them significant time in the application process.
- To apply to have your school’s program(s) listed, please complete the information below along with the required forms and appropriate non-refundable application fee (see enclosed fee and term schedule) to:

- On the NAMA Program Description Form *use a separate form for each program you would like to be listed:*
1. Put your school contact information
  2. Put the name of the program
  3. Put the number and description of the NAMA category that your program will be listed in.
  4. Write a 50 to 100 word paragraph describing the educational program
  5. Put the year the program was established

- Provide either a copy of your state issued license or a letter from the responsible state agency stating that no license is required for your school’s program.

- Include non-refundable application fee: *There is a separate fee for each program.* *Approved 3/11/2009*
